#### What do I need to know about the Ancestral Tourism market?

The following summary statistics have been taken from market research reports and reliable resources that the Information Service uses to compile industry information. They should give you an indication of how your industry is faring at present and whether there is demand for your type of business:

- Scotland's tourism market continued to post the strongest recovery into Q3 2023 (up 14% vs Q3 2019) with 1.4m visits. Spend reached a record £1.5bn (up 43% vs Q3 2019). In Q2 2023, the most common trip purpose for taking an overnight trip in Great Britain was visiting friends or family (10.3 million trips, 35% share). (Visit Britain, Great Britain Tourism Survey, October 2023).
- Over the next five years, tour operators will need to adjust packages, deals and holiday destinations to suit changing preferences. They'll strive to attain competitive advantages by integrating more personalised services, including mobile booking platforms, and offering more niche, specific tours. Industry revenue is forecast to rise at a compound annual rate of 3.7% over the five years through 2028-29 to reach £18.2 billion. (IBISWorld, Tour Operators in the UK, October 2023).
- The number of inbound tourists expected to the UK over the five years through 2023-24 is 39.5million people and is forecast to grow to 46.2million by 2028-29. The three main reasons that visitors come to the UK is for holidays, business or to visit friends and relatives. According to the International Passenger Survey, holidaying accounts for the majority of visits usually with 41% of the total, followed by visiting family and friends. (IBISWorld, International Tourist Numbers, August 2022).
- ♦ Historic houses and properties, visitor and heritage centres, and gardens saw the greatest annual increase in visitors in 2021 following the significant declines seen across the industry in 2020. Admissions to gardens increased by 40% in 2021. Admissions to wildlife attractions and zoos increased by 46% in 2021, with historic houses and castles increasing by 45%. (Mintel, Visitor Attractions UK, December 2022).
- ♦ Ancestral tourism is a growing and important market for Scotland. At least 40 million people across the globe able to lay claim to Scotlish ancestry. The main ancestral tourism source countries for Scotland are the USA, Canada, and Australia. Over 25% of respondents of these countries cited Scotlish ancestry as a major motivation for their trip. More than a third said their ancestors lived in Scotland. (Visit Scotland, *Ancestral Tourism Toolkit*).
- The national organisation for this industry is <u>Visit Scotland</u>. Other industry bodies include <u>Association of Genealogists and Researchers in Archives</u>, <u>Association of Independent Tour Operators</u>, <u>Scottish Tourism Alliance</u>, <u>Edinburgh Centre for Global History</u>, and <u>Highland Archive Centre</u>.

- ♦ Mintel Domestic Tourism UK (December 2023). 37% of respondents surveyed gave 'Discovering history/heritage' as one of the key factors in choosing a UK holiday in 2023. Key areas of strength for domestic tourism include its varied offer to suit all budgets, including lower cost breaks such as camping and holiday parks, alongside the growth of higher value sectors such as cottage holidays, wellness, and special interest breaks. City breaks, seaside breaks, and holiday cottages are the most popular UK trips. Summer 2023 saw the launch of the Kirkpatrick Coast-to-Coast cycle route, a new 250-mile route running across South Scotland from Stranraer to Eyemouth. VisitScotland expects the route to attract up to 175,000 new visitors to the region, with a direct spend of £13.7 million per year.
- ♦ Mintel Visitor Attractions UK (December 2022). The number of people visiting historic buildings and museums increased in the 12 months to August 2022 compared to the previous year. Museums gained an 8% increase, whilst historic buildings gained 6%. For many indoor attractions, 2022 marked the first year of doors being fully open for the entire year. It is expected that these attractions will remain popular options over the upcoming years due to many having no or low entry fees, which have become increasingly attractive for visitors amid the cost-of-living crisis.
- ◆ 1921 Scottish census (National Records of Scotland) was released in November 2022. This information provides a glimpse into the home and working lives of Scotland's people 100 years ago. Family-history website <a href="Scotland's People">Scotland's People</a> has been updated to include over 9000 volumes of enumeration district books, comprising more than 200,000 images of 4.8 million individual records. (<a href="www.scotlandspeople.gov.uk">www.scotlandspeople.gov.uk</a>.)

#### How can I find out about my competitors?

Immediate competition will be from other businesses in your local area. There are several online directories which can be used to find company information and generate lists easily and at no expense. Once you've identified who your competitors are, the next step is to gather information on the way they do business. Which services do they provide? How do they market themselves? How much do they charge?

To learn about your competitors:

- Look for articles or adverts in local newspapers, trade press and directories.
- Try to read their marketing material; if the company has an online presence, visit the company's website as a first port of call. Not only does it give you a better understanding of the company's activities, it can also offer a wealth of information such as a company history or staff biographies, as well as the company's partners or suppliers
- Search for information on limited UK companies via the <u>Companies House</u> website
- Gain an insight into your competitor's performance using credit checks and the accounts that limited companies are required to submit to Companies House each year.

- ♦ Information from the most recent census in 2011 is released via the official website. See in particular the <a href="Census Area Profiles">Census Area Profiles</a>. Clicking on your area of interest will give the latest population figures, including estimates by age.
- Understanding Scottish Places has interactive profiles of towns and cities across Scotland. It can be useful for understanding the interrelationships and flows between towns, and also gives comparisons between two or more places.
- <u>Scottish Government Statistics</u> provide accurate and up-to-date statistics on Scotland, covering population, health, education and housing.
- ♦ <u>The Scottish Household Survey</u> provides information on the structure, characteristics, attitudes and behaviour of Scottish households, both at a national and local level.
- Office for National Statistics (ONS) is the recognised national statistical body for the UK. ONS covers a
  wide range of demographic, economic and social issues at a UK level.
