## What do I need to know about the Botox market?

The following summary statistics have been taken from market research reports and reliable resources that the Information Service uses to compile industry information. They should give you an indication of how your industry is faring at present and whether there is demand for your type of business:

- Non-surgical cosmetic treatments from Botox, fillers to lasers and facial treatments are increasingly becoming more popular than their surgical alternatives. Consumers are moving away from procedures that will drastically change their looks, and instead are after subtle ways of achieving "tweaks" to enhance their appearance. (Mintel, Attitudes Towards Cosmetic Procedures UK, January 2021).
- The influence of social media boosts demand for cosmetic procedures. A surge in cosmetic treatments echoes the increasing pressure from social media to look perfect and youthful. Celebrity-led trends and the fear of 'aging out' have fuelled such treatments' demand. Concern over inadequate regulation plagues the industry. Lack of strict licensing that allows untrained individuals to administer cosmetic procedures has raised serious patient safety concerns. (IBISWorld, Cosmetic Surgeons Clinics in the UK, July 2023).
- The global botox market was valued at \$3,689.91 million in 2020 and is estimated to grow to \$4,362.18 million in 2025. This will create an incremental growth opportunity worth \$672.27 million between 2020 and 2025, which translates to around 19% of the market size in 2020. Europe contributed 16.14% to the overall market in 2020 and would decrease its contribution to 15.34% of the global botox market in 2025. (Technavio, Global Botox Market, 2021-2025)
- The national organisation for this industry is the <u>Association of Aesthetics, Injectables and Cosmetics</u>.
  Other industry bodies include <u>The British Association of Aesthetic Plastic Surgeons</u>, <u>British Association of Cosmetic Nurses</u>, <u>European Association of Plastic Surgeons</u> and <u>Save Face</u>.

Mintel – Beauty and Personal Care Retailing, UK (2023). Beauty spending rose by 8% to £5.7 billion in 2022, buoyed by ongoing interest in colour cosmetics, facial skincare and fragrances. Sales are boosted by the lipstick effect, as consumers continue to turn to beauty for an affordable mood boost, giving the market some protection from an income squeeze.

Mintel – Attitudes Towards Cosmetic Procedures, UK (January 2021). Experience of face-related surgical procedures is highest among younger generation aged 25-34. Many teenagers (the youngest age range) today are seeking nose enhancement, facelifts or removing fats to replicate celebrities' features or to look more like their own filtered pictures from Snapchat or Instagram. - Aesthetic Medicine <u>Scotland plans injectables regulation</u> (January 2020). Currently, clinics run by medical professionals who provide non-surgical cosmetic procedures are regulated by Healthcare Improvement Scotland (HIS). This article reviews the news that Scotland would be the first in the UK to introduce a licensing scheme to cover any practitioner administering injectables. The Scottish Government's <u>public consultation results</u> for this were published on July 2022.
- Aesthetic Medicine published an article in September 2022 on the <u>value of the global dermal fillers</u> <u>market</u>. The "market is expected to reach \$8.74 billion (£7.65bn) by 2029, at a CAGR of 7.4% during the forecast period, 2022-2029". This growth is encouraged by increased investment in R&D and an increase in popularity of procedures using hyaluronic acid fillers.

## How can I find out about my competitors?

Immediate competition will be from other businesses in your local area. There are several online directories which can be used to find company information and generate lists easily and at no expense. Many Local Authorities also publish local business directories on the web. Below are some key web resources:

- General business directories such as <u>Yell</u>, <u>Thomson Local</u> or <u>Google Maps</u>
- Trade specialists like <u>EuroPages</u> (European directory), <u>The Wholesaler</u> or <u>Free Index</u>
- Business to business (B2B) specialists such as <u>Kompass</u>

Likewise, your local Chamber of Commerce may publish a members' directory; find your local Chamber on the <u>Scottish Chambers</u> website.

Once you've identified who your competitors are, the next step is to gather information on the way they do business. Which services do they provide? How do they market themselves? How much do they charge?

To learn about your competitors:

- Look for articles or adverts in local newspapers, trade press and directories.
- Try to read their marketing material; if the company has an online presence, visit the company's website as a first port of call. Not only does it give you a better understanding of the company's activities, it can also offer a wealth of information such as a company history or staff biographies, as well as the company's partners or suppliers
- Search for information on limited UK companies via the <u>Companies House</u> website
- Gain an insight into your competitor's performance using credit checks and the accounts that limited companies are required to submit to Companies House each year.

- <u>Scottish Government Statistics</u> provide accurate and up-to-date statistics on Scotland, covering population, health, education and housing.
- The Scottish Household Survey provides information on the structure, characteristics, attitudes and behaviour of Scottish households, both at a national and local level.
- Office for National Statistics (ONS) is the recognised national statistical body for the UK. ONS covers a wide range of demographic, economic and social issues at a UK level.
