# What do I need to know about the counselling market?

The following summary statistics have been taken from market research reports and reliable resources that the Information Service uses to compile industry information. They should give you an indication of how your industry is faring at present and whether there is demand for your type of business:

- Over the five years through 2028-29, industry **revenue is forecast to rise** at a compound annual rate of 2.5% to reach £1.3 billion. The government pledged additional funding of £2.3 billion a year for mental health services by 2023-24 as part of its NHS Long Term Plan. It has also committed to providing £780 million over the three years through 2024-25 to rebuild the drug treatment system, including expanding treatment places by 20%. This funding may relieve some of the financial pressures currently facing facilities. However, Brexit and stikes across care services may threaten industry profitability, primarily by exacerbating current staff shortages. (IBISWorld, *Learning Disability, Mental Health & Substance Abuse Facilities in the UK*, July 2023).
- ↑ There is a growing focus on supporting employee wellbeing through physical and mental health prevention, and key issues for employers include reducing sickness rates and improving productivity. According to the ONS's latest data, mental health conditions including stress, anxiety and depression accounted for 12% of sickness in the workplace. When comparing reasons given for sickness absence in the public sector and private sector, mental health conditions were reported more frequently in the public sector (14% absences compared with 7.7% of absences in the private sector). (Mintel, Occupational Health UK May 2022).
- ◆ Despite some of these challenges, the industry revenue is projected to **grow** at a compound annual rate of **0.5% over the five years through 2023-24 to £627.1 million**. Factors such as rising unemployment, reduced employer confidence, and tight corporate budgets dented the demand for wellness services. The shift to remote work since the outbreak in 2020 continues to be a challenge to services in unprecedented ways. The corporate wellness industry has rebounded, with an **anticipated 3.0% growth rate in 2023-24** and has a bright future ahead. However, poor economic conditions, including high inflation in the two years through 2023-24, have caused businesses to cut their spending budgets and hamper industry demand. (IBISWorld, *Corporate Wellness Services in the UK*, July 2023).

- ♦ Mintel Private Healthcare in the UK (June 2022). The pandemic has led to the largest shift in business focus and priority towards employee health and wellbeing especially in mental health. Employees, themselves, are also becoming more observant of their own health which has significantly boosted growth in B2C healthcare most notably in areas such as private GP services, diagnostics, monitoring, and testing.
- ◆ IBISWorld Learning Disability, Mental Health & Substance Abuse Facilities in the UK (July 2023). Treating mental health conditions requires specialised staff that are scrutinised by the Care Quality Commission, so there's significant pressure on facilities. Degenerative health conditions like dementia, which can lead to mental health problems, are rising in line with the ageing population, boosting demand for facilities. Greater awareness of mental health issues, driven largely by campaigns led by high-profile figures like Prince William has increased demand.

### How can I find out about my competitors?

Business Gateway's online guide to <u>Competitor Analysis</u> explains how to find your competitors, how to research what they're doing and how to act on what you learn about them.

Immediate competition will be from other businesses in your local area. There are several online directories which can be used to find company information and generate lists easily and at no expense. Many Local Authorities also publish local business directories on the web. Below are some key web resources:

- General business directories such as <u>Yell</u>, <u>Thomson Local</u> or <u>Google Maps</u>
- Trade specialists like <u>EuroPages</u> (European directory), <u>The Wholesaler</u> or <u>Free Index</u>

Likewise, your local Chamber of Commerce may publish a members' directory; find your local Chamber on the Scottish Chambers website.

Once you've identified who your competitors are, the next step is to gather information on the way they do business. Which services do they provide? How do they market themselves? How much do they charge?

To learn about your competitors:

- Look for articles or adverts in local newspapers, trade press and directories.
- Try to read their marketing material; if the company has an online presence, visit the company's website as a first port of call. Not only does it give you a better understanding of the company's activities, it can also offer a wealth of information such as a company history or staff biographies, as well as the company's partners or suppliers
- Search for information on limited UK companies via the <u>Companies House</u> website
- Gain an insight into your competitor's performance using credit checks and the accounts that limited companies are required to submit to Companies House each year.

- ♦ <u>Understanding Scottish Places</u> has interactive profiles of towns and cities across Scotland. It can be useful for understanding the interrelationships and flows between towns, and also gives comparisons between two or more places.
- <u>Scottish Government Statistics</u> provide accurate and up-to-date statistics on Scotland, covering population, health, education and housing.
- ♦ <u>The Scottish Household Survey</u> provides information on the structure, characteristics, attitudes and behaviour of Scottish households, both at a national and local level.
- Office for National Statistics (ONS) is the recognised national statistical body for the UK. ONS covers a
  wide range of demographic, economic and social issues at a UK level.
