# What do I need to know about the Roofing Contractor market?

The following summary statistics have been taken from market research reports and reliable resources that the Information Service uses to compile industry information. They should give you an indication of how your industry is faring at present and whether there is demand for your type of business:

- Recovering construction activity has contributed to industry revenue climbing at an estimated CAGR of 1.1% over the five years through 2023-24, including growth of 2.9% in 2023-24, to £6.1 billion. The average profit margin is expected to be 11.6% in 2023-24. Over the five years through 2028-29, revenue is forecast to increase at a compound annual rate of 5.1% to reach £7.8 billion. Roofers have benefitted from rising demand from homeowners completing work on existing properties, as repair and maintenance work rose to 39.8% above the February 2020 level in June 2023. (IBISWorld, *Roofing Activities in the UK*, September 2023).
- ◆ Clay roof tiles accounted for 7.3% (£108.9m) of industry revenue for the Brick & Tile Manufacturing sector in the UK in 2023. Demand for clay roofing tiles has deteriorated since the popularity of high-density housing, which uses alternative materials not included in the brick and tile manufacturing industry, like roofing felt, coal tar pitch and glass. The development of sustainable products like solar, recycled and composite roofing is adding to the substitutes replacing clay tiles. (IBISWorld, *Brick & Tile Manufacturing in the UK*, January 2024).
- ♦ The global green roofs market was valued at \$10,434.55million in 2022 and is estimated to grow to \$18,541.24million in 2027. A building's roof that is partially or entirely covered with plants and a growing medium that is planted over a waterproofing membrane is referred to as a green roof. The benefits of green roofs are combined with solar photovoltaic systems, which can further improve the green ratings of buildings. Europe contributed 31.12% to the global green-roofs market in 2022, and its contribution will decline to 29.52% in 2027 within an expanding overall market, rising from \$3,247.23 million in 2022 to \$5,473.37 million in 2027. (Technavio, Global Green-Roofs Market 2023-2027).
- ♦ The majority of accredited installers of Solar-PV in the UK are tradesmen, often with a background in roofing or heating. A key challenge for contractors is to ensure there is a workforce large enough to meet demand and fill the skills gap. With a lack of investment in training and education programmes, many companies in the industry are struggling to find workers with the necessary skills and experience. (Mintel, Residential Small Scale Renewables UK, October 2023).
- ♦ The national organisation for this industry is the <u>Institute of Roofing</u>. Other industry bodies include <u>The National Federation of Roofing Contractors</u> (NFRC), the <u>Roof Tile Association</u> and the <u>Metal Cladding and Roofing Manufacturers Association</u>.

- ♦ IBISWorld Brick & Tile Manufacturing in the UK (January 2024). Commercial construction has struggled with remote working which reduces the need for office space. According to the ONS, private commercial new orders in October 2023 fell by 23% since February 2020. However, in 2022, the ONS noted a 15% output boost in the home repair and maintenance sector driven by the trend of hybrid or remote working. Companies operating within the clay brick and tile sector primarily cater to residential construction needs, focusing on small-scale projects such as home extensions that require bricks and roofing tiles, as well as interior renovations like bathroom and kitchen remodels that utilize ceramic tiles.
- ♦ IBISWorld Roofing Activities in the UK (September 2023). There's strong competition in the industry. This is a result of the high number of small roofing contractors that operate in the industry. The larger players are more resilient to price competition. This market fragmentation is displayed by 84.6% of roofers employing fewer than five people, and 94.1% employing fewer than 10. The average roofing enterprise earns just £550,000 annually.
- ◆ Technavio Global Roofing Market (2023-2027). Residential roofing materials often focus on aesthetics, durability, and insulation to provide protection and enhance the appearance of the building. Growing urbanization is primarily responsible for the rising popularity of residential buildings such as apartments, bungalows, and villas in emerging economies. By 2030, the percentage of people living in urban areas is expected to rise to 60%, according to the United Nations (UN). The global roofing market was valued at \$125.17 billion in 2022 and is estimated to grow to \$157.35 billion in 2027.

- ♦ The National Federation of Roofing Contractors Limited (www.nfrc.co.uk) Industry updates offering news such as "contractors continued to face challenges when trying to recruit people with the right skills. 27% of firms said they had found it difficult to employ slaters and tilers, while 16% said they had struggled with cladders" according to the latest State of the Roofing Industry report from NFRC and Glenigan, November 2023.

- ♦ National Careers Service, *Job Profiles: Roofer* (Roofer). A roofer's starting salary is around £17,000 and can progress with experience to around £35,000. Roofers normally work around forty-two hours per week.
- Office for National Statistics (ONS) Construction output in Great Britain: November 2023-short term measures of output by construction industry in November 2023. (ONS - Construction output UK).

## How can I find out about my competitors?

To learn about your competitors:

- Look for articles or adverts in local newspapers, trade press and directories.
- Try to read their marketing material; if the company has an online presence, visit the company's website as a first port of call. Not only does it give you a better understanding of the company's activities, it can also offer a wealth of information such as a company history or staff biographies, as well as the company's partners or suppliers
- Search for information on limited UK companies via the <u>Companies House</u> website
- Gain an insight into your competitor's performance using credit checks and the accounts that limited companies are required to submit to Companies House each year.

- <u>Scottish Government Statistics</u> provide accurate and up-to-date statistics on Scotland, covering population, health, education and housing.
- ♦ <u>The Scottish Household Survey</u> provides information on the structure, characteristics, attitudes and behaviour of Scottish households, both at a national and local level.
- Office for National Statistics (ONS) is the recognised national statistical body for the UK. ONS covers a
