What do I need to know about the Sandwich Bar market?

The following summary statistics have been taken from market research reports and reliable resources that the Information Service uses to compile industry information. They should give you an indication of how your industry is faring at present and whether there is demand for your type of business:

- ◆ Food outlets continue to be a popular lunchtime channel, with the number of Britons **eating in at food outlets growing by 3% to reach 41% in April 2023**, compared to 37% in March 2022. Spending on takeaway sandwiches, baked goods and hot drinks is being driven by those from households earning £50,000 or over, who are most likely to have ordered a takeaway for lunch from a sandwich/bakery shop (58% vs 50% of total) and coffee shop (42% vs 33% of total). (Mintel, *Attitudes to Lunch out of home UK*, June 2023).
- ◆ Sandwich and wrap sales have seen strong growth due to consumers seeking convenience and on-the-go food as their lives get busier. Changing consumer preferences and rising health consciousness has driven bakery cafes to innovate in introducing vegan, gluten-free and healthy alternatives. IBISWorld reports that within the Bakery Café industry, **bread and sandwiches** are expected to account for the **largest share of industry revenue in 2023-24, at 47.5% (£548.2m)**. (IBISWorld, *Bakery Cafes in the UK*, October 2023).
- ◆ Food markets sell a range of pizzas, sandwiches, and wraps with these products expected to account for **24.8% (£295.3m) of industry revenue in 2023**. People aged between 35 and 49 have the highest disposable incomes and are most likely to visit food markets during weekday lunchtimes as they seek a fun alternative to a packed lunch or meal deal. (IBISWorld, *Food Markets in the UK*, March 2023).
- ◆ In **2022, over £512m was spent by UK consumers on sandwiches, rolls, and baguettes**. This was a large **increase in value of roughly £66m** in comparison to the previous year. After a drop in spending in 2020, spending has been on an increase for two consecutive years in a row. In 2021, 2.9m people purchased from a coffee shop or sandwich bar 2-3 times a month. (Statista, *Food & Nutrition*, June 2023 and *Food & Drink Services*, February 2023.)
- ◆ Supermarkets are the most used retail channel for buying lunchtime foods, attracting 58% of category buyers. **Pre-packed sandwiches** are the most popular retail lunch choice, eaten by **37% of people**. Own-label dominates the pre-packaged fresh sandwiches market, reflecting the challenges brands face in creating tangible, inimitable points of difference. (Mintel, *Lunchtime Foods in Retail UK*, February 2022).

- ◆ **Mintel – Attitudes to Lunch out of Home UK (June 2023).** Packed lunches continue to be vastly popular, eaten by 77% of workers who don't currently work mainly/entirely at home. Therefore, this group of frugal working consumers will cut back on spending on lunchtime foodservice purchases and/or gravitate towards packing lunch at home to bring to their workplace, in a bid to offset rising costs. Highlighting fillings for sandwiches that contribute richly to the nutrition required from a meal at a low cost per meal should chime, as 66% of lunch eaters say it's important that their lunch is nutritionally rich.
- ◆ **Mintel – Bread UK (November 2022).** Bread is most likely to be used to make sandwiches or toast, by 83% and 77% of eaters of bread respectively, reflecting its continuing importance for breakfasts and lunches. Among the wider population, in April 2022, 48% of people ate lunch at home five or more times a week and 20% 3-4 times a week, highlighting the strength of demand for at-home lunch options. 66% of those who eat lunch at home had eaten a sandwich/wrap/open sandwich for an everyday occasion in April 2022, making it the most popular choice by some distance.
- ◆ **IBISWorld – Bread & Bakery Goods Production in the UK (August 2023).** Bread's staple status has kept sales resilient in the face of weak incomes and falling consumer spending during the cost-of-living crisis. Most people see it as a necessity – according to UK flour millers, 99.8% of UK households purchase bread regularly and will likely continue to purchase it regardless of price rises. Bread can be hard to differentiate, though newer trends have created alternative breads such as seeded, sourdough and other artisanal styles.

How can I find out about my competitors?

Business Gateway's online guide to [Competitor Analysis](#) explains how to find your competitors, how to research what they're doing and how to act on what you learn about them.

Immediate competition will be from other businesses in your local area. There are several online directories which can be used to find company information and generate lists easily and at no expense. Many Local Authorities also publish local business directories on the web. Below are some key web resources:

Likewise, your local Chamber of Commerce may publish a members' directory; find your local Chamber on the [Scottish Chambers](#) website.

Once you've identified who your competitors are, the next step is to gather information on the way they do business. Which services do they provide? How do they market themselves? How much do they charge?

To learn about your competitors:

- ◆ Look for articles or adverts in local newspapers, trade press and directories.
- ◆ Try to read their marketing material; if the company has an online presence, visit the company's website as a first port of call. Not only does it give you a better understanding of the company's activities, it can also offer a wealth of information such as a company history or staff biographies, as well as the company's partners or suppliers
- ◆ Search for information on limited UK companies via the [Companies House](#) website
- ◆ Gain an insight into your competitor's performance using credit checks and the accounts that limited companies are required to submit to Companies House each year.
